Because of Matt and Odle & Associates this beautiful firearm can be purchased from the Nebraska One Box Pheasant Hunt at such a discounted price.

Many of you purchased the 25th Anniversary Shotgun and have expressed interest in obtaining the same serial number for the 50th Anniversary Shotgun. We will try to honor these requests at **no additional charge**. We will keep a few Special Serial Numbers that will be auctioned at a later date.

At this time, we are only going to purchase 100 guns. If there are requests for more than 100 we can increase our order up to 150 for a limited time only. Consequently you need to get your request sent in as quickly as you can in order to ensure your purchase. We will not be able to purchase additional guns after we make our final order.

This is a very special offer and we encourage you to help us celebrate *our* history by purchasing the 50th Anniversary Browning Shotgun!

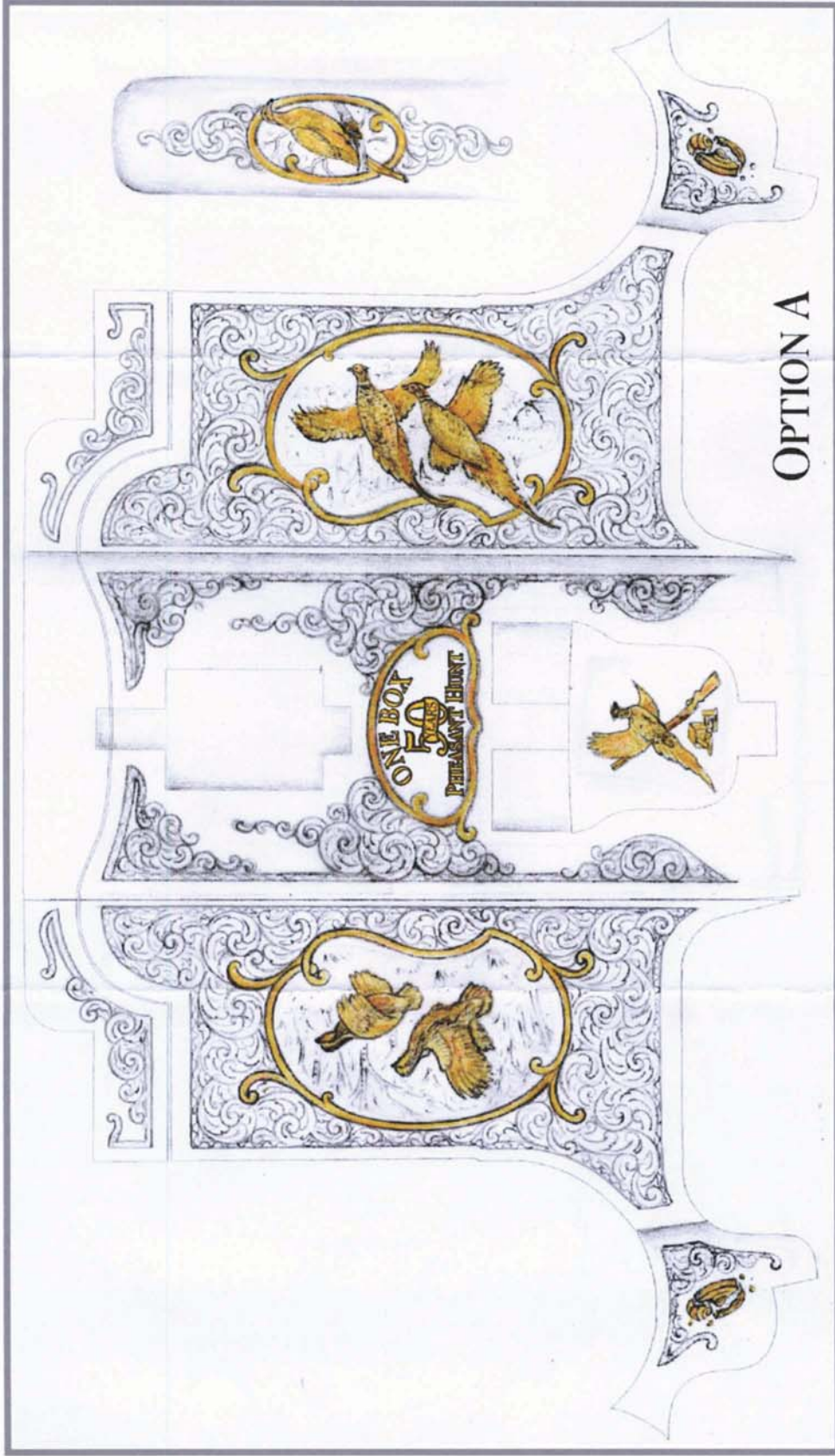
